\$125 Male Makeup & Hair

Intended for male presenting clients. Color correction and evening of skin and blemishes with foundation and concealer, shaping and filling in brows and facial hair, freshening up the lips and keeping skin shine free.

Does not include staying on set for touch ups

\$175 Makeup & Hair


Intended for female presenting clients. Color correction and evening of skin and blemishes with foundation and concealer, appropriate bronzing and blush, shaping and filling in brows and freshening up the lips.

Does not include lashes or staying on set for touch ups

\$225 Makeup & Hair + Touch Ups

Intended for female presenting clients. Color correction and evening of skin and blemishes with foundation and concealer, appropriate bronzing and blush, shaping and filling in brows and freshening up the lips. Includes 1 hour of staying on for touch ups and look changes after the initial styling has been completed.
